

LEGAL DESCRIPTION TEMPORARY CONSTRUCTION EASEMENT

BEING a 0.0202 acre tract of land situated in the S. Needham Survey, Abstract No. 1171, City of Keller, Tarrant County, Texas; said tract being part of Lot 2, Block A, Bear Creek 97, an addition to the City of Keller according to the plat recorded in Instrument No. D205242871 of the Official Public Records of Tarrant County, Texas; said tract being part of that tract of land described in Special Warranty Deed to G&E Healthcare Reit Medical Portfolio 2, LLC recorded in Instrument No. D208256449 of the Official Public Records of Tarrant County, Texas; said tract being more particularly described as follows:

BEGINNING at a 5/8" iron rod found at the north east corner of said Lot 2; said point also being in the west right-of-way line of S Elm Street (a variable width right-of-way);

THENCE South 0°22'07" East, along the said west line of S Elm Street, a distance of 72.23 feet to a 5/8-inch iron rod with "KHA" cap set for corner at the beginning of a non-tangent curve to the right; said point being the southeast corner of said Lot 2, Block A; from which point a 1/2" iron rod found at the intersection of the south right-of-way line of Bear Creek Parkway and the west right-of-way line of Whitley Road bears South 0°22'07" East, 13.09 feet, thence South 2°04'19" East, 77.80 feet;


THENCE in a southwesterly direction, with said curve to the right, having a central angle of 7°59'15", a radius of 40.50 feet, a chord bearing and distance of South 65°59'32" West, 5.64 feet and an arc distance of 5.65 feet to a 5/8-inch iron rod with "KHA" cap set for corner at the beginning of a compound curve to the right;

THENCE in a southwesterly direction, with said curve to the right, having a central angle of 3°48'32", a radius of 785.50 feet, a chord bearing and distance of South 71°53'26" West, 52.21 feet and an arc distance of 52.22 feet to a 5/8-inch iron rod with "KHA" cap set at the beginning of a non-tangent curve to the left in the said north line of Bear Creek Parkway;

THENCE in a southwesterly direction along the said north line of Bear Creek Parkway and with said curve to the left, having a central angle of 7°17'25", a radius of 386.11 feet, a chord bearing and distance of South 76°36'17" West, 49.09 feet and an arc distance of 49.13 feet to a point for corner;

THENCE North 14°58'27" West, departing the said north line of Bear Creek Parkway, a distance of 3.00 feet to a point for corner at the beginning of a non-tangent curve to the right;

THENCE in a northeasterly direction, with said curve to the right, having a central angle of 2°15'08", a radius of 389.11 feet, a chord bearing and distance of North 74°06'06" East, 15.29 feet and an arc distance of 15.29 feet to a point for corner;

THENCE North 75°13'40" East, a distance of 66.87 feet to a point for corner.

THENCE North 38°05'17" East, a distance of 30.51 feet to a point for corner;

THENCE North 0°22'07" West, a distance of 54.16 feet to a point for corner;

THENCE South 87°52'50" East, a distance of 5.00 feet to the POINT OF BEGINNING and containing 882 square feet or 0.0202 acres of land, more or less.
