

RESOLUTION NO.

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE BID FROM C GREEN SCAPING, LP, OF FORT WORTH, TEXAS, FOR THE CONSTRUCTION OF THE "PLAYFUL PUPPY" SCULPTURE PLAZA IN AN AMOUNT NOT TO EXCEED \$83,565.00; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL CONTRACT DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, a request for sealed bids for the "Playful Puppy" Sculpture Plaza was duly advertised in accordance with State law, and three (3) sealed bids were received, opened, and bidder names read aloud at 2:00 p.m., on July 21, 2020; and

WHEREAS, the three (3) sealed bids have been reviewed by city staff and the project architect, with C Green Scaping submitting the lowest bid; and

WHEREAS, after review of the three (3) sealed bids by the city staff and the architect it is determined that the bid from C Green Scaping, LP, of Fort Worth, Texas, in an amount not to exceed \$83,565.00 is the most qualified and responsible bid; and

WHEREAS, funding for the sculpture plaza is available in the Public Arts Development Fee Fund; and

WHEREAS, the Keller Public Arts Board has reviewed and approved the sculpture plaza design.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the bid from C Green Scaping, LP, of Fort Worth, Texas, for the construction of the "Playful Puppy" sculpture plaza in an amount not to exceed \$83,565.00; and further authorizes the City Manager to execute all contract documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of said sculpture plaza shall be paid from the Public Arts Development Fee Fund.
