A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS APPROVING AMENDMENT NO. 1 TO THE INTERLOCAL AGREEMENT FOR COMBINED PUBLIC SAFETY DISPATCHING AND JAIL SERVICES FOR THE CITIES OF KELLER, SOUTHLAKE AND COLLEYVILLE, TEXAS, TO INCLUDE COMBINED JAIL SERVICES FOR THE CITY OF ROANOKE, TEXAS, AT THE CITY OF KELLER POLICE FACILITY; AND AUTHORIZING THE CITY MANAGER TO EXECUTE SAID AGREEMENT ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, it has been determined by the City of Keller that it is in the best interest of the citizens therein to amend the Interlocal Agreement for Combined Public Safety Dispatching and Jail Services to include the Jail Services for the City of Roanoke, at the Keller Police Facility, 330 Rufe Snow Drive; and

WHEREAS, the City Council approved the Interlocal Agreement for Combined Public Safety Dispatching and Jail Services for the City of Southlake and the City of Colleyville by Resolution No. 2974, on August 3, 2010; and

WHEREAS, upon review and consideration by the City Council of the City of Keller, Texas, it has been determined to be in the best interest of the Cities of Keller, Southlake and Colleyville to combine Public Safety Dispatching and Jail Services, and to include Jail Services for the City of Roanoke, in accordance with the terms and conditions set forth in said Agreement attached hereto as Exhibit "A".

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves Amendment No. 1 to the Interlocal Agreement for Public Safety Dispatching and Jail Services for the Cities of Keller, Southlake and Colleyville, Texas, to include Jail Services for the City of Roanoke, at the City of Keller Police Facility; and further authorizes the City Manager to execute said Agreement on behalf of the City of Keller, Texas.
