

ORDINANCE NO. 1983

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING CERTAIN AMENDMENTS TO THE FISCAL YEAR 2019-20 ANNUAL OPERATING BUDGET FOR THE CITY OF KELLER, TEXAS, IN ACCORDANCE WITH ARTICLE VIII, SECTION 8.13, OF THE KELLER CITY CHARTER.

WHEREAS, the annual budget for the City of Keller, Texas, was adopted by Ordinance No. 1905, by the City Council, dated September 17, 2019, in accordance with the Keller City Charter; and

WHEREAS, additional expenditures from various funds are proposed for consideration by the Mayor and City Council; and

WHEREAS, notice of a public hearing before the City Council of the City of Keller, Texas, was published in a newspaper of general circulation in the City of Keller at least ten (10) days before such hearing, in accordance with Article VIII, Section 8.13 of the Keller City Charter; and

WHEREAS, said notice of public hearing was published in the *Fort Worth Star-Telegram* on Sunday, August 30, 2020; and

WHEREAS it is proposed that the 2019-20 Annual Budget be amended in accordance with the Keller City Charter.

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves certain amendments to the Fiscal Year 2019-20 Annual Operating Budget and the Fiscal Year 2019-20 Capital Improvements Program, in accordance with Article VIII, Section 8.13, of the Keller City Charter.

Section 3: THAT, the additional sums specified below are hereby proposed to be appropriated from the respective funds on behalf of the City of Keller, Texas:

**General Fund (100) proposed amendments (Total Increase \$ -):**

Up to \$1,000,000 – To be transferred to the Keller Self Insurance Fund based upon available salary savings at the end of the fiscal year.

**Facilities/General Governmental Capital Improvements Project Fund (105) proposed amendments (Total Decrease \$2,182,722):**

\$2,182,722 – Decrease in revenue related to a transfer-out to the Facilities/Enterprise Capital Project Fund for Pointe projects and a transfer-out to the Water-Wastewater System Capital Improvement Project Fund for a Municipal Service Center (MSC) project.

\$2,182,722 – Decrease in expenditures related to a transfer-out to the Facilities/Enterprise Capital Project Fund for Pointe projects and a transfer-out to the Water-Wastewater System Capital Improvement Project Fund for a MSC project.

**Facilities/Enterprise Governmental Capital Improvements Project Fund (106) proposed amendments (Total Increase \$2,182,722):**

\$2,082,722 – Increase in revenue related to a transfer-in from the Facilities/General Capital Project Fund for Pointe projects.

\$2,082,722 – Increase in expenditures related to a transfer-in from the Facilities/General Capital Project Fund for Pointe projects.

**Keller Self Insurance Fund (129) proposed amendments (Total Increase Up To \$1,200,000):**

Up to \$1,200,000 – Increase in revenue related to a transfer-in from the General and Water-Wastewater Utility Funds based upon available actual salary savings at the end of the fiscal year.

**Street System Capital Improvements Project Fund (170) proposed amendments (Total Increase \$58,989):**

\$58,989 – Increase in revenue related to the use of interest income to fund the Bear Creek/Keller Smithfield Signal

\$58,989 – Increase related to increased signal equipment costs for the Bear Creek/Keller Smithfield Signal.

**Water-Wastewater Utility Fund (200) proposed amendments (Total Increase \$ -):**

Up to \$200,000 – To be transferred to the Keller Self Insurance Fund based upon available salary savings at the end of the fiscal year.

**Water-Wastewater System Capital Improvement Project Fund (206)  
proposed amendments (Total Increase \$246,173):**

\$146,173 – Increase in revenue related to the use of interest income to fund the Walker Development Agreement / Utility Extension project.

\$100,000 – Increase in revenue related to a transfer-in from the Facilities/General Capital Project Fund for a Municipal Service Center (MSC) project.

\$146,173 – Project costs related to the Walker Development Agreement / Wastewater Extension project.

\$100,000 – Increase in expenditures related to a transfer-in from the Facilities/General Capital Project Fund for a Municipal Service Center (MSC) project.

Section 4: THAT, the additional sums provided in Section 3 above are hereby authorized from existing funds available within the respective fund or thru an approved transfer of funds to the respective fund as stated in Section 3.

Section 5: THAT, should any part, portion, section, or part of a section of this Ordinance be declared invalid, or inoperative, or void for any reason by a court of competent jurisdiction, such decision, opinion, or judgment shall in no way affect the remaining provisions, parts, sections, or parts of sections of this Ordinance, which provisions shall be, remain, and continue to be in full force and effect.

Section 6: THAT, all ordinances and appropriations for which provisions have heretofore been made are hereby expressly repealed if in conflict with the provisions of this Ordinance.
