WHEREAS, THE CITY OF KELLER, being the owner of the land s' wn on this plat within the area described by metes and bounds as follows:

Being a tract of land situated in the S. Needham Survey, Abstract No. 1171, Tarrant County Texas, and being all of that certain tract of land described in a deed to the City of Keller, Texas as recorded in Volume 8444, Page 1646, County Records, Tarrant County, Texas. Said tract is more particularly described as follows:

Beginning at a 5/8" iron with cap set at the northeast corner of said City of Keller tract, said point also being the northwest corner of Lot 1, Block 12, Meadowlands, an addition to City of Keller as shown on the map recorded in Volume 388-164, Page 19, said County records;

Thence South with the westerly line of said Meadowlands, 724.60 feet to a 5/8" iron with cap set in the centerline of Redbud Drive;

Thence West, 441.38 feet to a 5/8" iron with cap set at the beginning of a curve to the right;

Thence 198.61 feet with the arc of said curve to the right to a 5/8" iron with cap set. Said curve has a radius of 900.00 feet, a central angle of 12° 38' 38", and a long chord which bears N 83° 40' 41" W, 198.21 feet;

Thence N 77° 21' 22" W, 303.00 feet to a 1/2" iron found at the beginning of a non-tangent curve to the left;

Thence 121.37 feet with the arc of said curve to the left to a 5/8" iron with cap set. Said curve has a radius of 550.00 feet, a central angle of 12° 38' 38", and a long chord which bears N 06° 19' 19" E, 121.13 feet;

Thence North, 520.46 feet to a 5/8" iron with cap set in the southerly right-of-way line of Johnson Road (a 60 foot wide public right-of-way);

Thence S 89° 43' 34" E with said southerly right-of-way, 920.71 feet to the point of beginning and containing 15.000 acres.

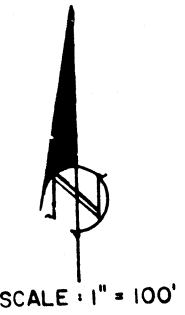
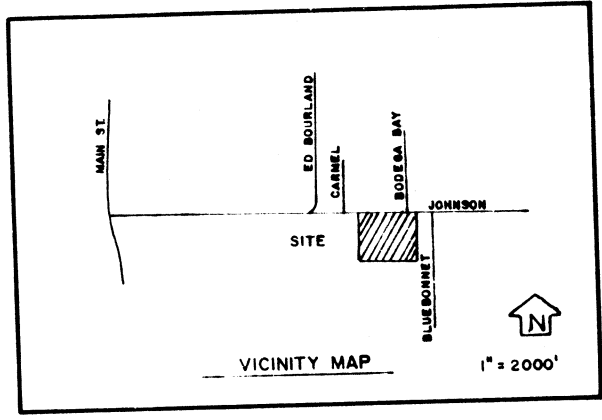
