I am the property owner at 926 Cobblestone Parks Drive, Keller, TX 76248. Approximately September 2, 2020, Mr. Jeff Abate came to my door asking me to sign a petition supporting the building of a 1500 sq ft barn. He stated that since the city only allows 1200 sq ft, he needed property owner's agreement for the extra 300 feet. The barn had NOT YET BEEN BUILT. I was confident that city permitting regulations would be followed and that safety concerns would be addressed including any drainage issues.

I have subsequently found out that a 2000 sq ft metal accessory building was ALREADY COMPLETED when he requested my signature.

I respectfully request that my name be REMOVED from the September 2, 2020 petition Mr. Abate submitted in support of his structure. I have since signed a petition opposing the SUP application.

It is a large building that will be used to store both hay and gas driven farm equipment and, as he previously stated, will have electricity. Please consider potential safety issues as you discuss his request.

I hope all the parties in the surrounding neighborhoods can work together to mitigate any potential problems that easily could have been avoided by following the rules.


