Complete Trailers of Texas is under an active contract with the property owner (Woodall Properties) with an active lease on the property located at 1425 S. Main Street in Keller. We are a trailer distributor that focuses on premium quality products to a wide range of customers. We had acquired a SUP back in 2019, but unfortunately due to the extreme time it took Woodall Properties to bring the location up to code our SUP has expired. Therefore, we are applying for it once again.

Complete Trailers TX is an offshoot from our initial location in Denver, CO. Opened in 2012, Complete Trailers CO has become a destination for customers in search of quality trailers that they can't find anywhere else. Due to the success in Denver, the decision was made to open a 2nd location in Ft. Worth, TX in 2016.

By the end of 2019, Complete Trailers TX generated revenue of \$8.3 Million. The majority of our customers are in the DFW area, but we also touch other large markets throughout Texas including San Antonio, Houston and Austin. Texas comprises about half of the total revenue generated for both locations.
