

RESOLUTION NO. 4311

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, CANVASSING THE GENERAL ELECTION DULY HELD IN THE CITY OF KELLER, TEXAS, ON THE 3RD DAY OF NOVEMBER 2020, TO FILL THE THREE (3) YEAR TERMS FOR MAYOR, CITY COUNCIL PLACE 5, AND CITY COUNCIL PLACE 6.

WHEREAS, a General Election was duly held in the City of Keller, Texas, on the 3rd day of November, 2020, to elect a City Council Member to fill the three (3) year terms for Mayor, Place 5, and Place 6; and

WHEREAS, the City Council has met and canvassed the votes cast in said election; and

WHEREAS, such canvass shows the following results:

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the above canvass be, and the same is hereby approved.

Section 3: THAT, the following be, and is hereby declared to have been elected to the office of City Council Place 5, to serve for a three (3) year term expiring May, 2023:

Section 4: THAT, the following be, and is hereby declared to have been elected to the office of City Council Place 6, to serve for a three (3) year term expiring May, 2023:

**City Council Place 6**

Section 5: THAT, as a result of such election for the position of Mayor, no person received a majority of the votes cast. Therefore, a Runoff Election will be called by the City Council of the City of Keller, Texas, for Mayor.
