

RESOLUTION NO. 4312

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, CALLING A RUNOFF ELECTION TO FILL THE OFFICE OF MAYOR FOR THE CITY OF KELLER, TEXAS, TO BE HELD ON DECEMBER 8, 2020, AS SET FORTH BY THE CHARTER AND THE TEXAS ELECTION CODE.

WHEREAS, a General Election was duly held in the City of Keller, Texas, on the 3rd day of November, 2020 to fill the offices of Mayor, City Council Place 5, and City Council Place 6 as set forth by the Charter and the Texas Election Code; and

WHEREAS, the City Council has met and canvassed the votes cast and declared that no candidate received a majority of the votes cast in said election for Mayor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: **Election Ordered.**

(a) A Runoff Election shall be held in the City of Keller, Texas on December 8, 2020, to elect a person to fill the office of Mayor, to serve until May, 2023, or until his successor is duly elected and qualified.

(b) Said election shall be held by Tarrant County pursuant to the Joint Election Agreement and Contract for Election Services, with respect to such Runoff Election approved by the City Council of the City of Keller, Texas and Tarrant County Elections Administrator.

Section 3: **Runoff Election Candidates.** Candidates to be running in the Runoff Election on December 8, 2020 are as follows:

Armin Mizani

Section 4: **Election Day Polling Places and Election Hours.** Election Day voting shall be conducted at Keller Town Hall, 1100 Bear Creek Parkway, Keller, Texas 76248. Voters may also vote at any Tarrant County Election Day polling locations due to joint elections with other political subdivisions, and pursuant to the Joint Election Agreement and Contract for Election Services with Tarrant County. Other Election Day polling locations may be found on the Tarrant County Elections Administration website.

Voting shall be conducted between the hours of 7:00 A.M. and 7:00 P.M. on Tuesday, December 8, 2020.

Section 5: **Election Officers.** The election officers for each polling place shall be appointed and compensated pursuant to the Joint Election Agreement and Contract for Election Services with the Tarrant County Elections Administrator, for said runoff election on December 8, 2020.

Section 6: a. **Early voting by personal appearance.**
Early voting by personal appearance shall be conducted at Keller Town Hall, 1100 Bear Creek Parkway, Keller, Texas 76248, beginning on Tuesday, May 30, 2017 and ending on Tuesday, June 6, 2017 between the following hours listed below:

- c. **Early voting ballot board.** The Early Voting Ballot Board shall be appointed and designated in accordance with the provisions of the Joint Election Agreement and Contract for Election Services with Tarrant County.

Section 7: **Method of Voting.** Tarrant County's voting equipment will be utilized for said election, and shall be conducted in accordance with the Texas Election Code.

Section 8: **Governing Law.** The election shall be held as set forth by the Charter and the Texas Election Code, and all resident registered voters of the City shall be eligible to vote in said election.

Section 9: **Effective Date.** This resolution shall be effective upon its adoption.
