

ORDINANCE NO. 1995

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING A SPECIFIC USE PERMIT (SUP) FOR WINDSHIELDS R US TO OPERATE AN AUTOMOBILE REPAIR, SALES, AND SERVICE USE; LOCATED IN AN APPROXIMATELY 2,500 SQUARE-FOOT BUILDING ON AN APPROXIMATELY 1.67 ACRE-TRACT, ON THE WEST SIDE OF SPORTS PARKWAY, APPROXIMATELY 250 FEET SOUTHWEST OF THE INTERSECTION OF KELLER PARKWAY AND SPORTS APRKWAY, LOCATED AT 112 SPORTS PARKWAY AND ZONED C (COMMERCIAL), IN THE CITY OF KELLER, TARRANT COUNTY, TEXAS; PROVIDING A PENALTY; AND AUTHORIZING PUBLICATION.

WHEREAS, Mike Pennington, applicant; and Tamara Thomas, owner; submitted an application to the City of Keller to request a Specific Use Permit to operate an Automobile Repair shop in the Commercial zoning district (SUP-20-0020); and

WHEREAS, the applicant's services will include window tinting, glass repair, video calibration, and storage for necessary equipment; and

WHEREAS, notice of public hearings before the Planning and Zoning Commission and City Council were sent to real property owners within three-hundred feet (300') of the property herein described at least ten (10) days before such hearings; and

WHEREAS, the public hearings were held before both the Planning and Zoning Commission and the City Council and no comments from the public were offered in either support or opposition; and

WHEREAS, the Planning and Zoning Commission made a recommendation to approve the Specific Use Permit by a vote of 7-0; and

WHEREAS, the City Council finds that the Specific Use Permit furthers the purpose of zoning as set forth in the Unified Development Code;

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, in accordance with the Unified Development Code, the City Council of the City of Keller, Texas hereby authorizes approval of a Specific Use Permit (SUP) for an Automobile Repair, Sales and Service use, for Windshields R Us, proposed in an approximately 2,500 square-

foot space, on an approximately 1.67 -acre property, located on the west side of Sports Parkway, approximately 250 feet southwest of the intersection of Keller Parkway and Sports Parkway, zoned Commercial (C), located at 112 Sports Parkway, in the City of Keller, Tarrant County, Texas, and incorporated herein.

Section 3: THAT, any person, firm, or corporation violating any of the provisions of this Ordinance, as read together with the Unified Development Code and accompanying map thereto, shall be guilty of a misdemeanor and upon final conviction therefore shall be fined in a sum not to exceed Two Thousand Dollars (\$2,000.00). Each and every day such violation continues shall constitute a separate offense and shall be punishable as such hereunder.

Section 4: THAT, the City Secretary is hereby authorized and directed to cause publication of the descriptive caption and penalty clause hereof as an alternative method of publication provided by law.

AND IT IS SO ORDAINED.
