RESOLUTION NO. 4319

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING AN AGREEMENT WITH DATAVOX, OF HOUSTON, TEXAS, FOR THE PURCHASE, PROGRAMMING, AND INSTALLATION OF AUDIO VISUAL, PAGING, AND ACCESS CONTROL EQUIPMENT AND SOFTWARE FOR THE KELLER SENIOR ACTIVITIES CENTER, THROUGH THE STATE OF TEXAS DEPARTMENT OF INFORMATION RESOURCES (DIR) COOPERATIVE PURCHASING PROGRAM, IN A TOTAL AMOUNT OF \$160,829.76; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to install audio visual, paging, and access control equipment and software in the Keller Senior Activites Center, for the Information Technology Department; and
- WHEREAS, the City's allowance budget within the Senior Activities Center construction budget provided for the purchase of said Datavox services; and
- WHEREAS, the purchase of said audio visual, paging, and access control equipment and software from Datavox, of Houston, Texas, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, has been determined to be the best value and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas, hereby approves the agreement with Datavox, or Houston, TX, for the purchase, programming, and installation of audio visual, paging, and access control equipment in the Keller Senior Activites Center, in the amount of \$160,829.76, through the State of Texas Department of Information Resources (DIR) Cooperative Purchasing Program, for the Information Technology Department; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of said purchase of audio visual, paging, and access control equipment and software, in the amount of \$160,829.76, for the

Information Technology Department, shall be paid from the City's allowance budget within the Senior Activities Center construction budget, budgeted therefor.
