RESOLUTION NO. 4331

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF FOUR (4) STRYKER POWER-PRO XT COTS, TO INCLUDE A SEVEN (7)-YEAR SERVICE AGREEMENT, FOR THE EMERGENCY MEDICAL SERVICES DIVISION OF THE FIRE DEPARTMENT, IN THE TOTAL AMOUNT OF \$87,674.60; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to purchase four (4) Stryker Power-PRO XT cots for the Emergency Medical Services Division of the Fire Department; and

WHEREAS, the City of Keller Ambulance Cost Settlement Reimbursement Fund Budget provides for the purchase of said equipment for the Emergency Medical Services Division of the Fire Department; and

WHEREAS, the purchase of the Stryker Power-PRO XT cots are a sole source vendor and will be purchased in the amount of \$87,764.60 and has been determined to be the lowest and most responsible method of purchasing.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.

Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the purchase of four (4) Stryker Power-PRO XT cots, to include a seven (7)-year service agreement, for the Emergency Medical Services Division of the Fire Department, in the total amount of \$87,764.60; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.

Section 3: THAT, the cost of purchasing four (4) Stryker Power-PRO XT cots for the Emergency Medical Services Division of the Fire Department, in the total amount of \$87,764.60, shall be funded from the Fire Department Ambulance Cost Settlement Reimbursement in the Public Safety Special Revenue Fund.
