Hours of Operation:

Liquor store hours are set by the State of Texas and are Monday through Saturday 10:00AM until 9:00PM. The store is <u>not open</u> on Sundays.

About Goody Goody:

Founded in 1964 by Joe and Mary Jane Jansen, Goody Goody Liquor is a family-owned and operated pioneer in the Texas wine, beer and spirits industry. Their story began in Dallas when Joe purchased Goo Goo Liquors in 1964 as somewhat of a hobby or second job. While Joe and Mary Jane worked full time at other businesses in Dallas during the day, they would get off of work around 4:30PM, go to Goo Goo Liquors and work from 5:00PM until 10:00PM at night. Mary Jane would run the cash register and Joe would make deliveries.

At the time, the store was a meager 15-by-50 foot space located on Greenville Avenue. To save \$600 on new signage, Joe was able to change the name of the store by simply adding "dy" to the original name; thus, Goody Goody was born.

Goody Goody is privately owned and continues to be owned by Joe Jansen for the last 55 years. To this day Joe is very active in the company and involved in every aspect of the business seven days a week. Unfortunately Mary Jane passed away a few years back, up until then Mary Jane was also involved in the business as she had been from the very start.


The Ownership is local and the Owner goes above and beyond to be a good neighbor and participate in the community or local activities in many different capacities.






