RESOLUTION NO. 4422

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS, APPROVING THE PURCHASE OF REPLACEMENT CARDIO EQUIPMENT, IN THE TOTAL AMOUNT OF \$195,244.31, FOR THE KELLER POINTE RECREATION AND AQUATIC CENTER, FROM MARATHON FITNESS, OF SUGARLAND, TEXAS, THROUGH THE BUYBOARD COOPERATIVE PURCHASING PROGRAM; AND AUTHORIZING THE CITY MANAGER TO EXECUTE ALL PURCHASE DOCUMENTS RELATING THERETO ON BEHALF OF THE CITY OF KELLER, TEXAS.

- WHEREAS, the City Council of the City of Keller, Texas, has deemed it necessary and in the best interest of the citizens of the City of Keller to replace the existing cardio equipment at The Keller Pointe Recreation and Aquatic Center to provide safe and operable equipment for the patrons; and
- WHEREAS, the Fiscal Year 2021-22 Annual Budget provides for the purchase of said replacement equipment for The Keller Pointe Recreation and Aquatic Center; and
- WHEREAS, the purchase from Marathon Fitness, of Sugar Land, Texas, through the Buy Board cooperative purchasing program has been determined to be the lowest and most responsible method of purchasing therefor.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF KELLER, TEXAS:

- Section 1: THAT, the above findings are hereby found to be true and correct and are incorporated herein in their entirety.
- Section 2: THAT, the City Council of the City of Keller, Texas hereby approves the purchase of replacement cardio equipment, in the total amount of \$195,244.31, for The Keller Pointe Recreation and Aquatic Center, from Marathon Fitness, of Sugar Land, Texas, through the BuyBoard cooperative purchasing program; and further authorizes the City Manager to execute all purchase documents relating thereto on behalf of the City of Keller, Texas.
- Section 3: THAT, the cost of said purchase of replacement cardio equipment, in the amount of \$195,244.31 for The Keller Pointe Recreation and Aquatic Center, shall be paid from The Keller Pointe funds, budgeted therefor.
