  - A motion was made by Council Member Tag Green, seconded by Council Member Chris Whatley to approve the Minutes of the Tuesday, November 21, 2017 Regular City Council Meeting. The motion carried unanimously.
- 2. Consider a resolution approving the purchase of two (2) replacement pickup trucks and two (2) new pickup trucks through the Texas Procurement and Support Services Cooperative Purchasing Program (TxSmartBuy) and authorizing the City Manager to execute all related purchase documents on behalf of the City of Keller, Texas.
  - A motion was made by Council Member Tag Green, seconded by Council Member Chris Whatley to approve Resolution No. 3962 approving the purchase of two (2) replacement pickup trucks and two (2) new pickup trucks through the Texas Procurement and Support Services Cooperative Purchasing Program (TxSmartBuy) and authorizing the City Manager to execute all related purchase

documents on behalf of the City of Keller, Texas.. The motion carried unanimously.

3. Consider approving an ordinance of the City of Keller Code of Ordinances by amending Chapter 18, Article II, Speed Limits, Section 18-200, various speed limits on public streets; establishing a prima facie speed limit for vehicles on North Tarrant Parkway from the 800 to 1100 blocks, under provisions of section 545.356(b-1) of the Texas Transportation Code; providing a severability clause; a penalty; authorizing publication; and establishing an effective date.

A motion was made by Council Member Tag Green, seconded by Council Member Chris Whatley to approve Ordinance No. 1871 of the City of Keller Code of Ordinances by amending Chapter 18, Article II, Speed Limits, Section 18-200, various speed limits on public streets; establishing a prima facie speed limit for vehicles on North Tarrant Parkway from the 800 to 1100 blocks, under provisions of section 545.356(b-1) of the Texas Transportation Code; providing a severability clause; a penalty; authorizing publication; and establishing an effective date. 1. PUBLIC HEARING: Consider an ordinance approving a Specific Use Permit (SUP) for a 4,272 square foot detached accessory dwelling unit before constructing a new home, located on approximately 3.57-acres, on the north side of Simmons Drive, one thousand four hundred feet (1,400') east of the Simmons Drive and Rufe Snow Drive intersection, at 1021 Simmons Drive, being Lot 13R, Block 1, Rolling Oaks Estates, and zoned SF-36 (Single Family Residential - 36,000 square foot minimum). Trent and Mary Petty, owners. Greg Wright, Providential Land Development, LP, applicant. (SUP-17-0020)

Mrs. Trina Zais, Director of Public Services and Community Development, gave a presentation relating to a request for an ordinance approving a Specific Use Permit (SUP) for a 4,272 square foot detached accessory dwelling unit before constructing a new home, located on approximately 3.57-acres, at 1021 Simmons Drive.

Mayor Pat McGrail opened the public hearing. No public comments were received. A motion was made by Council Member Armin Mizani, seconded by Council Member Ed Speakmon, to close the public hearing. The motion carried unanimously.

A motion was made by Council Member Ed Speakmon, seconded by Council Member Tag Green, to approve Ordinance No. 1872 approving a Specific Use Permit (SUP) for a 4,272 square foot detached accessory dwelling unit before constructing a new home, located on approximately 3.57-acres, on the north side of Simmons Drive, one thousand four hundred feet (1,400') east of the Simmons Drive and Rufe Snow Drive intersection, at 1021 Simmons Drive, being Lot 13R, Block 1, Rolling Oaks Estates, and zoned SF-36 (Single Family Residential - 36,000 square foot minimum) with the following conditions and variances:

 A condition for a 4,272 square-foot accessory dwelling unit to be constructed prior to the construction of the primary dwelling unit to be considered.

- 2. A condition for the combined square footage of all accessory buildings to exceed fifty percent (50%) of the square footage of the primary structure to be considered.
- 3. A variance for the accessory dwelling unit to exceed fifteen feet (15') in height shall be allowed.
- A variance to waive the eight percent (80%) masonry requirement on the exterior of the accessory dwelling unit as shown in "Exhibit A" shall be allowed.
- 5. A variance for the accessory dwelling unit to have a metal roof shall be allowed.
- 6. A variance for the front-facing garage door exposure to exceed one hundred forty-four (144) square feet, up to two hundred sixteen (216) square feet shall be allowed.
- 7. The building permit for the main structure and the accessory dwelling structure shall be submitted at the same time.
- 8. The construction on the main structure shall begin within one (1) year of issuing the building permit, or the SUP will be expired.

# The motion carried unanimously.

PUBLIC HEARING: Consider an ordinance approving amendments to the City of Keller Unified Development Code, adopted by Ordinance No. 1746, dated July 7, 2015; to amend the process for residential building permits by amending Article 4, Development Procedures and Requirements for Application Submittals, Section 4.13 - Single-Family Residential Construction Process; and by amending Article 5, Subdivision Design and Improvement Requirements, Section 5.10 -Residential Subdivisions Thoroughfare Screening and Landscaping; and to amend requirements for private street developments, by amending Article 5, Subdivision Design and Improvement Requirements, Section 5.04 Private Street Developments; providing a conflicting ordinance clause; authorizing publication; and establishing an effective date.
