Mr. Jack Murray, Contour Real Estate & Development and Mr. Larry Jackson, David Weekly Homes, addressed the City Council regarding the proposal.

A motion was made by Council Member Tag Green, seconded by Council Member Sean Hicks, to approve Ordinance No. 1899 approving a Planned Development Amendment from PD-SF-8.4 (Planned Development - Single Family Residential -8,400 square-foot minimum) to PD-SF-8.4 (Planned Development - Single Family 8,400 square-foot minimum), amending the Concordia Development (Ordinance No. 1888), to amend their development standards, on an approximately 23.067-acre property, being a portion of Lot 1, Block 1, A Church for the Communities. located on the north side of North Tarrant Parkway. 1,000 feet from Rufe Snow Drive and North **Tarrant Parkway** approximately intersection, addressed as 1870 Rufe Snow Drive with the following condition and variance:

- 1. The proposed maximum house pad width shall be fifty feet (50').
- 2. A variance is requested to allow forty-five percent (45%) for the main building and fifty-five percent (55%) including accessory buildings, driveways, and parking areas.
