Community Development Director Julie Smith gave a presentation relating to the request for a SUP for Just for Grins to operate a Dentist Office at 466-468 North Main Street.

Mayor Pat McGrail opened the public hearing.

Mr. Dan Taylor, 112 Johnson Road, expressed concerns with the potential of the building being two-stories, parking, and drainage.

Mr. Michael Wright, Architect, and Dr. Jonathan Angwin, owner/applicant, addressed the City Council regarding the one-story building and parking.

A motion was made by Council Member Chris Whatley, seconded by Council Member Beckie Paquin, to close the public hearing. The motion carried unanimously.

Council Member Tag Green expressed concerns with notices to residents being misleading, and suggested to notice the public again with an included illustration of the building, and to table the item.

Council Member Sheri Almond and Council Member Chris Whatley asked for and received clarification on the building set-backs.

Council Member Beckie Paquin asked for and received a visual depiction of where the building and parking will be on the lot, and also asked for clarification from the Community Development Director on standard practice of public notice.

Council Member Tag Green clarified that the building will be located on the western portion of the property, and not directly behind any of the residences.

Mayor Pat McGrail clarified the intent of the public notices and that the City Council is only taking action on the use for a dentist office at the location.

Council Member Tag Green asked for and received clarification that the SUP application is the only action that requires public notice.

A motion was made by Council Member Mitch Holmes, seconded by Council Member Sheri Almond, to approve Ordinance No. 1977 authorizing a Specific Use Permit (SUP) for a Dental Office use, for Just for Grins, proposed in an approximately 10,750 square-foot building, on an approximately 2.21 -acre property, located on the east side of North Main Street, approximately 250 feet southeast of the intersection of North Main Street and Johnson Road, zoned Old Town Keller (OTK), located at 466-468 North Main Street. The motion carried unanimously.
