#### **SPECIAL MEETING 7:00 P.M.**

In accordance with Order of the Office of the Governor issued March 16, 2020 and March 19, 2020, the Keller City Council will conduct the meeting scheduled at 7:00 p.m. on Tuesday, March 24, 2020 by telephone conference in order to advance the public health goal of limiting face-to-face meetings (also called "social distancing") to slow the spread of the Coronavirus (COVID-19). There will be no public access to the location described above. A recording of the telephonic meeting will be made, and will be available to the public.

#### **A. CALL TO ORDER – Mayor Pat McGrail**

#### **B. PERSONS TO BE HEARD**

The public will be permitted to offer public comments telephonically as provided by the agenda and as permitted by the presiding officer during the meeting. Speakers will be required to state their name and address prior to making comments.

Mayor Pat McGrail anounced that due to public health and safety concerns the possibility for a May election date with early voting in April is no longer a viable option.

Mr. Armin Mizani, 896 Randol Mill Avenue expressed his graditude towards the City, City

Council, and City staff regarding the response to the COVID-19 Public Health Emergency.

Mr. Justyn Jaworski, 300 Woodland Trail, expressed his concerns and asked for clarification regarding the City's response to the Public Health Emergency.

City Manager Mark Hafner presented the options for the May 2, 2020 General Election. Currently the date that the City could hold this election would be November 3, 2020, but it is recommended to provide for an earlier date, if approved by the Governor.

A motion was made by Mayor Pro Tem Sean Hicks, seconded by Council Member Beckie Paquin, to approve Resolution No. 4222 postponing the General Election called for May 2, 2020, for the offices of Mayor, City Council Place 5, and Place 6, to November 3, 2020, unless an earlier date, occurring after May 2, 2020, but before November 3, 2020, is authorized by the Governor of the State of Texas, in which case the General Election originally scheduled for May 2, 2020, shall be held on such earlier date.

The motion carried unanimously.
