Administrative Services Manager Sarah Hensley gave a presentation relating to public art benches for the planned 12 pedestrian benches on Bates Street. Mrs. Hensley informed the City Council that after reviewing several options, staff is proposing the city issue a call for art to have an artist design, fabricate and install the benches. Mrs. Hensley also shared that the Public Arts Board discussed the project at their Sept. 8, 2021 meeting and recommended moving forward with the call for art. The estimated the cost per bench should be set between \$6,000 and \$8,000 per bench, and the funding is available for all 12 benches in the Public Art Development Fee Fund. Discussion was held by the City Council.

The City Council directed staff to move forward with the call for art to have an artist design, fabricate and install the 12 pedestrian benches for Bates Street.
