### D. WORK SESSION

1. Discuss Membership with the Greater Keller Chamber of Commerce.

Mayor Armin Mizani addressed the Greater Keller Chamber of Commerce Board members in the audience and stated that he valued the relationship between the City of Keller and the Chamber of Commerce. He added that what is voiced in the roles as elected officials, and what is voiced in the roles as chairpersons, is reflective of the relationship between the two organizations. Council Member Sean Hicks expressed his concerns with the City of Keller overstepping boundaries with the Chamber of Commerce. Council Member Tag Green, Council Member Shannon Dubberly, Council Member Jessica Juarez, and Mayor Pro Tem Ross McMullin all expressed their desire to work with the Chamber with a homogeneous view that supports the community's values; however, supported a resolution that would terminate the relationship between the City of Keller and the Chamber of Commerce should divisiveness continue.

Mayor Armin Mizani requested that the incoming chairperson from the Chamber of Commerce inform him the outcome of the Chamber's meeting scheduled later in the month.

Fire Marshal Debra Crafton presented a proposed amendment to the 2021 International Fire Code (IFC) relating to food truck inspections. She explained that with the addition of Section 319.2.1 Inspections to the IFC, Keller Fire-Rescue would accept a passing inspection report performed by another North East Fire Department Association (NEFDA) city, provided that city was enforcing the same adopted codes as Keller. Fire Marshal Crafton added that there were only two other NEFDA cities who had adopted the 2021 IFC, that the majority of NEFDA cities were currently under the 2018 IFC.

The City Council directed Fire Marshal Crafton to research and compare the variances between the 2018 IFC and the 2021 IFC.

1. A variance to allow a dead end or stub street (without a cul-de-sac) without the provision of future access to adjacent vacant land areas shall be allowed.

The motion carried unanimously.
