Action Requested:

Consider a resolution approving a Chapter 380 Economic Development Program Agreement, for a City of Keller Façade Improvement Matching Grant, in the amount of \$5,000.

Background:

Edward and Donna Kirkwood of Kirkwood Investments, LLC are requesting a \$5,000 façade improvement matching grant for improvements to the property located at 110 Lamar Street. The total estimated cost of all facade improvements is \$24,634.

Façade Improvements for Reimbursement include adding stone and tile to the exterior and adding on a patio.

Financial Impact:

The remaining program budget for the FY 2018-19 is \$27,957.50. If all façade improvement matching grant requests on this agenda are approved, the remaining budget would be \$8,807.50.
