Background:

To continue to provide exceptional amenities to the citizens of Keller, staff was directed to coordinate a parking lot improvement project for Parking Lot "E" at the Keller Sports Park, and Shady Lane North and the Maintenance Building Parking Lots of Bear Creek Park.

The engineering firm of Neel-Schaffer, Inc., has previously performed the Parking Lot Improvement engineering for the Fiscal Year 2019-20 Parking Lot Improvement Project at the Keller Sports Park.
